



REMÉE vanity tops, soaking tubs, wall panels, and accessories are warranted to the original purchaser to be free from defects in material and workmanship for a period of five (5) years from date of purchase shown on purchaser's receipt. This warranty is not transferable to anyone else and a copy of the receipt must be submitted at the time a warranty claim is made.

During the warranty period, REMÉE Casting will replace, FREE OF CHARGE, any marble product which proved defective in material and or workmanship under normal installation, use, and service. Upon receipt of written authorization from REMÉE, replacements can be obtained by returning the defective piece.

THIS WARRANTY IS LIMITED TO DEFECTIVE PIECE REPLACEMENT ONLY. LABOR CHARGES AND/OR DAMAGE INCURRED IN INSTALLATION, REPAIR OR REPLACEMENT AS WELL AS ANY INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES OF ANY KIND OR NATURE ARE EXCLUDED.

Any damage to the vanity top, soaking tubs, wall panel, or accessory as a result of misuse, abuse, neglect, accident, improper installation or handling WILL VOID THIS WARRANTY.

Except as otherwise required or provided, by applicable law, the foregoing warranty is in lieu of all other express or implied warranties of any kind, including, but not limited to, merchantability and or fitness for any particular purpose or use. All other such warranties, express or implied, are hereby excluded.

Caution: Some curling or straightening irons may leave burn marks on this material if left in direct contact. It is recommended that a heat resistant pad or towel be used to rest curling or straightening irons on when in use.

*Due to the nature of cast polymer products, we require an allowance for an 1/8" variance on the measurement of each finished piece. The only way to get the product to the exact size is to sand it down, leaving an unfinished edge.*



## **One Year Warranty**

### **WARRANTY COVERAGE:**

Products manufactured by companies other than Remée Casting are warranted to the original purchasing consumer for a period of one year from the date of purchase against avoidable and unnatural defects in material and workmanship. This warranty does not cover the installation of such products; nor does this warranty cover any product used or installed in connection with such products. This warranty does not apply to defects arising from miss-use, abuse, accident, alteration, improper care or failure to perform reasonable and necessary maintenance after installation.

ANY IMPLIED WARRANTIES ARE ALSO LIMITED IN DURATION TO A PERIOD OF ONE YEARS FROM DATE OF PURCHASE WARRANTOR SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL COSTS, EXPENSES, OR DAMAGES INCURRED BY PURCHASE

### **WARRANTY PERFORMANCE:**

If any of the products covered by this warranty shall, under normal use and within the periods of time set forth above, prove defective, such parts will be repaired or replaced by the Warrantor without charge. The Warrantor will not provide, or pay the cost of removal of defective products, installation of repaired or replaced products, or the transportation of either repaired, replaced, or defective products. You (the Warrantee) must provide any pay for such removal, installation or transportation.
